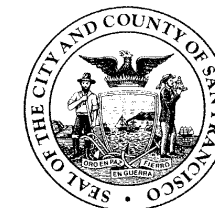

My goal in applying for the Health Service Board is to protect and enhance the health benefits of employees, retirees and their dependents. With 39 years experience working for the City and County of San Francisco, I have a record of successfully working with entities to defend and improve health benefits.

My career with the City, including tenures with the Health Service System (HSS), MUNI, and the Office of the Controller, affords me valuable ability and unique insight. I have experience with labor union trust funds, budgets, HSS processes, and specifically developing improvements in the HSS membership and accounting systems. This compliments my experience as the Chief Assistant Controller for San Francisco, where I played a central role in financial and internal control audits of the HSS. Additionally I helped write and pass the charter amendment that protected retiree cost of living allowances.
