The individual or entity selected to author a Proponent or Opponent argument may, under certain circumstances, assign the right to author the argument, or the rebuttal argument, to another individual or entity. The assignment must be in writing, and submitted to the Department of Elections no later than the ballot argument's deadline.

**NOTE:** The individual or entity to whom the argument is assigned must be eligible to submit ballot arguments.
