MOHCD's Draft Digest Recommendations for Ballot Simplification Committee

The Way It Is Now: The City and County of San Francisco ("City") does not provide legal representation to San Francisco tenants who face eviction from their homes. The City does fund nonprofit organizations that provide free legal representation to some San Francisco tenants who face eviction: funds nonprofit organizations to provide the following legal services to San Francisco tenants who face eviction from their homesin eviction lawsuits. There are different levels of legal services provided to tenants at certain stages of the eviction process, but not all tenants have access to legal representation at all stages of the eviction process.

- All tenants have access to low-cost assistance with completing a required court form after they have been served an eviction lawsuit.
- All tenants have access to free legal representation for a mandatory settlement meeting before the lawsuit goes to trial.
- <u>A limited number of eligible tenants have access to free legal representation at all stages of the eviction process.</u>

Before a landlord may evict a tenant, the landlord must give the tenant a written notice that the landlord intends to do so. If a the tenant does not move after receiving that eviction notice, by the end of this notice, then the landlord may file a lawsuit asking a court to order eviction.

The City's Charter establishes the City's budget process that sets the funding for all City programs. Under that process, the Board of Supervisors and the Mayor must approve the City's budget each year.

The Mayor's Office of Housing and Community Development administers City programs to create and preserve affordable housing in San Franciscocreate affordable housing opportunities for families and individuals and to strengthen our communities physically, socially, and economically.

The Proposal: Proposition _____ would require the City to establish, fund and run a program to provide legal representation <u>for all stages of the eviction process</u> for all residential tenants <u>in San Francisco</u> whose landlords are attempting to evict them from where they live facing eviction.

<u>Proposition</u> would require the City to provide a lawyer for a tenant within 30 days after the tenant receives an eviction notice or a lawsuit seeking eviction, whichever is sooner. The lawyer would provide legal representation to the tenant until the notice is withdrawn or the lawsuit is resolved. <u>Proposition</u> Program would not require the City to provide legal representation be available to tenants who reside in the same dwelling unit with their landlord or master tenant. Funding for the program would be at the discretion of the Mayor and Board of Supervisors through the City's budget process.

Proposition ____ would require the <u>Mayor's Office of Housing and Community DevelopmentCity</u> to implement this program within 12 months after <u>Proposition _____it</u> becomes effective.
