#### Agenda for August 1 through August 5, 2022

These summaries, or "digests," which are prepared at public meetings, are printed in San Francisco's Voter Information Pamphlet, which is mailed to every registered voter before the election. The Committee must complete its digests no later than 85 days before the election.

Pursuant to the 45th Supplement to the Mayoral Proclamation Declaring the Existence of a Local Emergency, the Ballot Simplification Committee shall meet remotely July 25 through August 12, 2022.
