Still need to register to vote?

Register to vote online at *registertovote.ca.gov* or contact the Department of Elections to request a paper registration form. To receive a ballot in the mail, you must register by May 23, 2022. After that date, you will need to register and vote in person at the City Hall Voting Center or a polling place.



Vote by mail is now permanent. Per recent changes to state law, every registered voter will be mailed a ballot. Any voter may still choose to vote in person.

What's on the ballot?

In the June 7, 2022 election, all voters citywide will vote on contests to fill state and federal offices and the office of the San Francisco City Attorney. There will also be eight local ballot measures, including a recall measure for the San Francisco District Attorney.

Have my voting districts changed?

Your voting districts may have changed as a result of post-census redistricting processes.

San Francisco will begin using the new State Assembly and U.S. Congressional District maps beginning with the June 7, 2022 election and will begin using the new BART and local Supervisorial District maps beginning with the November 8, 2022 election. There will be no changes to the boundary lines of San Francisco's Board of Equalization or State Senate Districts.

Since the combination of voting districts in which you live determines both your current representatives and the candidates listed on your ballot when you vote, your June and/ or November 2022 ballots may have different candidates than would have been listed under the old voting district lines. However, not all voters in the city will be affected by the new voting district lines.

How can I cast my ballot?

1. Vote by Mail

Around May 9, 2022, the Department of Elections will send a vote-by-mail packet, with an official ballot, instructions, an "I voted!" sticker, and a postage-paid return envelope to every locally registered voter. The online accessible vote-by-mail system – with screen readable ballots compatible with personal assistive devices – will also become available to all voters at *sfelections.org/Access*.

Whether you use a paper or accessible ballot, you will need to complete three steps:

	Paper Vote-by-Mail Ballot	Accessible Vote-by-Mail Ballot
O Mark your Ballot	Read the instructions printed on your ballot before making your selections.	Go to <i>sfelections.org/Access</i> to access your ballot and read the online instructions before making your selections.
Prepare your Envelope	Remove the receipt from the top of your ballot and place the ballot in the return envelope. Complete and sign the voter section of the envelope, then seal it.	Print out your ballot and place it in the return envelope. Complete and sign the voter section of the envelope, then seal it.
③ Return your Ballot	To be counted, ballots returned by mail must be postmarked no later than Election Day, June 7 (Check pickup times if you mail your ballot on Election Day). To be counted, ballots returned in person must be hand-delivered to an official ballot drop box* or a polling place by 8 p.m. on Election Day, June 7.	



*The Department of Elections now offers 34 official ballot drop boxes in neighborhoods across San Francisco. These boxes will be open 24 hours a day from May 9 through 8 p.m. on Election Day, June 7. For locations, visit *sfelections.org/BallotDropOff*.

2. Vote Early at City Hall

The City Hall Voting Center will be open to all San Franciscans who wish to register to vote or vote in person, use accessible voting equipment, receive personal assistance, or return their mailed ballots:

- Every weekday, from May 9 to June 7 (except May 30, Memorial Day), from 8 a.m. to 5 p.m.
- Last two weekends, on May 28-29 and June 4-5, from 10 a.m. to 4 p.m.
- On Election Day, Tuesday, June 7, from 7 a.m. to 8 p.m.

3. Vote at your Polling Place

Between 7 a.m. and 8 p.m. on Election Day, 588 polling places will be open for in-person voting and ballot drop-off services. The address of your assigned polling place, along with accessibility information, will be printed on the back cover of your Voter Information Pamphlet (mailed in May). You can also visit *sfelections.org/MyVotingLocation* to find your assigned polling place.
