



Ballot Pickup Authorization Form for Non-Citizen Voters February 15, 2022, School Board Recall Election

IMPORTANT NOTICE FOR NON-UNITED STATES CITIZENS

Any information you provide to the Department of Elections, including your name and address, may be obtained by Immigration and Customs Enforcement (ICE) and other agencies, organizations, and individuals. In addition, if you apply for naturalization, you will be asked whether you have ever registered or voted in a federal, state, or local election in the United States. You may wish to consult with an immigration attorney, an organization that protects immigrant rights, or other knowledgeable source before providing any personal information to the Department of Elections and before registering to vote in San Francisco Board of Education Elections. You can find a list of nonprofit organizations that specialize in protecting the rights of immigrants on sfelections.org.

Beginning January 18, any non-citizen voter may use this form to authorize a spouse, child, parent, grandparent, grandchild, sibling, or a person residing in their household to pick up a ballot from the City Hall Voting Center and deliver it to them.

The authorized person must bring this completed form to the Voting Center during voting hours:

- Weekdays, January 18-February 14, from 8 a.m. to 5 p.m.
- Two weekends, February 5-6 and February 12-13, from 10 a.m. to 4 p.m.
- Election Day, Tuesday, February 15, from 7 a.m. to 8 p.m.

您向選務處提供的任何資料，包括您的姓名與地址，可能會被移民及海關執法局（Immigration and Customs Enforcement，簡稱ICE）以及其他機構、組織和個人取得。此外，如果您申請歸化入籍，您將會被詢問是否曾經在美國的聯邦、州或地方選舉中登記或投票。在您向選務處提供任何個人資料，以及登記參加三藩市教育委員會選舉的投票之前，不妨向移民律師、移民權利的維權組織、或其他熟悉此事務人士諮詢意見。您可以在 sfelections.org 找到專門保護移民權利的非營利組織名單。

從 1 月 18 日起，任何非公民選民均可以填寫此授權書，以授權其配偶、子女、父母、祖父母、孫子女、兄弟姐妹或任何與其居住於同一地址的人，替其到市政廳投票中心領取選票，並把選票送交選民。

獲授權者必須帶同選民填妥的授權書到投票中心。投票中心開放時間如下：

- 星期一至星期五，1 月 18 日至 2 月 14 日，上午 8 時至下午 5 時
- 選舉日之前的兩週末，2 月 5 至 6 日及 2 月 12 至 13 日，上午 10 時至下午 4 時
- 選舉日，星期二，2 月 15 日，上午 7 時至晚上 8 時


