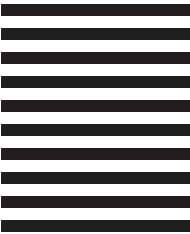

Can you use the Non-Citizen Voter Registration Form to register to vote in the School Board recall election on February 15, 2022?

ALL of the statements below must be true:

- I am not a United States citizen
- I live in San Francisco
- I do not plan to move before February 15, 2022
- I am the parent, legal guardian, or caregiver* of a child who lives in San Francisco and will be under 19 years old on February 15, 2022
- I will be at least 18 years old on February 15, 2022
- I am not in prison for a felony
- I have not been found mentally incompetent to vote by a court

*A caregiver is someone who signs the affidavit to enroll a minor in school and consents to school-related medical care on behalf of the minor. This is determined by state law, in CA Family Code §6550-6552.

Registering to vote with the Non-Citizen Voter Registration Form does not permit you to vote in any other federal, state, or local elections.

If someone helped you fill out or deliver the Non-Citizen Voter Registration Form, the person who helped must provide the following information:

ચૂંટણી વિભાગ(ડિપાર્ટમેન્ટ ઓફ ઇલેક્શન)ને તમે આપેલી તમારા નામ અને સરનામા સહિતની તમામ માહિતિ ઇમિગ્રેશન અને કર્ટમ વિભાગ(આઈસ) અને અન્ય એજંસીઓ, સંસ્થાઓ અને વ્યક્તિઓ પ્રાપ્ત કરી શકે છે. વધુમાં, જો તમે નાગરિકત્વ મેળવવાની કાર્યવાહી (naturalization)માટે અરજી કરો તેમાં પણ પૂછવામાં આવશે કે તમે ક્યારેય પણ યુનાઈટેડ સ્ટેટ્સમાં ફેડરલ, રાજકીય કે સ્થાનિક ચૂંટણીમાં નોંધણી કરી હતી કે મતદાન કર્યું હતું. તમે ઈચ્છો તો, ચૂંટણી વિભાગ(ડિપાર્ટમેન્ટ ઓફ ઇલેક્શન)ને તમારી વ્યક્તિગત માહિતિ આપતાં પહેલાં અને સાન ફ્રાન્સિસ્કો બોર્ડ ઓફ એજ્યુકેશનની ચૂંટણીમાં નોંધણી કરાવતાં અગાઉ, ઇમિગ્રેશનનાં વકીલ, કોઈ સંસ્થા કે જે વિદેશીઓનાં હક્કોનાં રક્ષણ કરતી હોય, અથવા અન્ય જાણકાર સ્ત્રોતની સલાહ મેળવી શકો છો. તમે sfelections.org પર નહિ નફો ધરાવતી સંસ્થાઓ કે જે વિદેશીઓનાં હક્કોનાં રક્ષણ કરવામાં નિપુણ હોય તેની યાદી શોધી શકો છો.



INSTRUCTIONS

- In **Section A**, review eligibility requirements and complete fields.
- In **Section B**, affirm under penalty of perjury that you are eligible to vote in the School Board recall election and that all information is true and correct. Sign and date.
- Return this form to the Department of Elections.** To return by mail, fold the form to connect the red triangles on the left, and then connect the blue dots. Use tape to seal. To return in person, visit the Department's office in City Hall, Room 48.
Once the form is processed, the Department will mail you a Notification Letter to confirm your registration. If you do not receive the letter within a week, call (415) 554-4375.

All registered voters in San Francisco will be mailed ballots for the February 15 election. In-person voting services will also be available at the voting center and polling places. For information, visit sfelections.org/NCV.

A Eligibility Requirements: I am not a United States citizen; I live in San Francisco; I do not plan to move before February 15, 2022; I will be at least 18 years old on February 15, 2022; I am the parent, legal guardian, or legally recognized caregiver of a child who currently lives in San Francisco and will be under the age of 19 on Election Day, February 15, 2022; I am not in state or federal prison for a felony; I have not been found mentally incompetent to vote by a court.
