Ballot Pick-Up and Delivery Authorization Form
November 5, 2019, Election

Beginning October 7, a voter may use this form to authorize a spouse, child, parent, grandparent, grandchild, sibling, or a person residing in the same household as the voter to pick up a ballot from a Voting Center and deliver it to the voter.

To pick up a ballot, the authorized person must bring the completed form to either the City Hall Voting Center or the San Francisco State University (SFSU) Voting Center. Hours are below.
