如要領取選票,獲授權者必須帶同選民填妥的授權書到市政廳投票中心,開放時間如下:

- 選舉日之前的兩個週末(2月5日至6日和2月12日至13日),上午10時至下午4時
- 選舉日(星期二,2月15日),上午7時至晚上8時

## **Ballot Pickup Authorization Form**

February 15, 2022, Consolidated Special Municipal Election

If you are unable to pick up your vote-by-mail ballot yourself, this form allows you to authorize a representative to do it for you. You may also choose to access your ballot via the Accessible Vote-By-Mail (AVBM) system at *sfelections.org/access*. The AVBM system allows any voter to download and mark a screen readable ballots; marked ballot must be printed and returned to the Department of Elections.

Beginning January 18, any voter may use this form to authorize a spouse, child, parent, grandparent, grandchild, sibling, or a person residing in their household to pick up a ballot and deliver it to them.

Beginning February 8, voters who are unable to vote in person at a polling place or the City Hall Voting Center due to confinement in a hospital, another facility, or at home because of a medical emergency may use this form to authorize anyone 16 years of age or older to pick up a ballot and deliver it to them.

The authorized person must bring this completed form to the City Hall Voting Center, which will be open as follows:

- Every weekday (January 18 to February 14), from 8 a.m. to 5 p.m.
- The last two weekends (February 5-6 and February 12-13), from 10 a.m. to 4 p.m.
- On Election Day (Tuesday, February 15), from 7 a.m. to 8 p.m.
